




We believe that the audit evidence obtained by us, is sufficient and appropriate to provide a basis for our audit opinion.

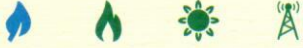
